Hi Greg,

In response to your questions raised, we have been provided the following information by Governance:

#### 1. We would like to clarify why an organisation that is non-commercial and not-for-profit cannot hire at your venue

Public liability insurance protects council and your association if a person suffers an injury or damage to their property.

Council's public liability insurer only provides limited coverage for casual hirers and the policy does not extend to incorporated associations.

To minimise exposure to risk for both council and hirers of our venues, council requires coverage from any organisation that is not covered under our Public Liability policy. This also includes bookings where low risk activities will be taking place.

## 2. if there is any flexibly in the application of your booking conditions in future?

No – the rules of coverage for Public Liability are set by our insurer and we are unable to have this changed.

I'm sorry to be the bearer of bad news but as explained above, under our current operating guidelines, the fact that your Incorporated organisation does not have Public Liability Insurance will prevent the hire of Council's facilities.

#### Dear Kate

I am following up this correspondence that you sent to Tony Gibson (Acting President, OSCAR at the time) late last year when OSCAR had enquired about hiring your facility for a state election Candidate Forum.

As we do not have Public Liability we were unable to hire the venue which was regrettable as it would have been an ideal location for a coast-wide forum.

I was overseas at the time but wanted to take the opportunity to follow this up and Peta Pitcomb suggested I contact you in the first instance.

We would like to clarify why an organisation that is non-commercial and not-for-profit cannot hire at your venue (and others under the control of the SCRC no doubt) just because it is incorporated.

I am not sure if you are aware but incorporated bodies are not legally required to have Public Liability insurance, provided its members are aware of that fact, unless your incorporated association owns or leases land, or holds land in trust which we do not (see <a href="QLD Government website">QLD Government website</a>). While our lack of Public Liability limits the community facilities we can use, we cannot justify the significant expense of such insurance given our limited financial resources. This would also be true of many of our member organisations.

I would suggest that the type of event we are likely to require a booking for (a meeting, no physical activity, no fee charged) would have a very low risk associated with it and no more than an identical organisation that was seeking a booking but which was not incorporated.

Therefore, I am wondering if there is any flexibly in the application of your booking conditions in future? If this is not in your hands, can you tell me who in the Council we could contact to pursue this matter further? The present policy denies organisations like ours being able to use ratepayer funded facilities and denies you room hire income.

I understand you spoke to Peta on the phone yesterday but wasn't sure if this email was before or after? Sorry if it's a double up of information but in regards to your query, Council's Casual Hirer Coverage is restricted to hirers who can be described as non-commercial, not incorporated, not for profit and irregular users of Council facilities. No cover is provided for incorporated bodies, therefore OSCAR Inc would not be eligible for coverage under this policy.

I'm sorry we weren't able to accommodate you this time and wish you all the best in finding a suitable location for the forum.
