"City Hall" community consultation Subject:

At the most recent OSCAR general meeting it was resolved that I should write to you seeking clarification on what form of community consultation is going to occur in relation to the Maroochydore CBD Council Chamber project

OSCAR is supportive, in principle, of the development of a suitable headquarters for the Sunshine Coast Regional Council and recognises the logic of locating such a building in the emerging CBD. The central location of Maroochydore on the Sunshine Coast, proximity to public transport options and capacity for Council to encourage further development in the CBD all seem potentially sound reasons for pursuing this project.

We are very keen to hear from you on how the general community will be consulted in this development. In the following table we have identified relevant references to the "community" in the Sunshine Coast City Hall Building - High Level Project Plan (included as an attachment to the Agenda of the Ordinary Meeting dated 11 October 2018 - Item 8.4.4) and questions we would appreciate answers to:
