Correspondence is placed on the Members section of the website as it is received or sent.



TO: The Honourable the Speaker and Members of the Legislative Assembly of Queensland

Queensland residents draws to the attention of the House the South East Queensland (SEQ) residents' concerns about Queensland's planning laws which favour developers' interests over community interests leading to loss of:

- Quality of life, heritage and neighbourhood character
- Green open space and conservation areas
- Koala and other wildlife habitat
- Convenient and timely travel
- Services and infrastructure capacity to meet population needs

Your petitioners accept the benefits of the urban footprint infill concept but request the House, as a matter of great importance and urgency, to review and improve planning laws so that they put community interests first, through:

1. Enhancing community amenity, heritage and neighbourhood character

- 2. Providing green and open spaces in SEQ at world's best practice standard
- 3. Integrating land and transport planning to avoid transport congestion
- 4. Conserving koala and other wildlife habitat
- 5. Ensuring adequate provision of infrastructure and services to support development

6. Increasing certainty to communities in relation to development compliance with designated building heights, density, setbacks, off-street parking and private community space

7. Making most developments subject to genuine public scrutiny and objection

8. Requiring all development to declare their public and community benefits in terms other than jobs creation.

*9. Requiring full transparency of council and government decision-making including genuine community consultation* 

10. Protecting the community from impacts of climate change.

# SEQ on track to accommodate future growth



#### Land Supply and Development Monitoring report

The <u>2018 Land Supply and Development Monitoring report</u> for South East Queensland (SEQ) has been released.

The online report shows the region is on track to supply enough land to support the dwellings and jobs required for future population growth in the region.

The data also shows more diverse housing stock, like units, is being approved. This is in line with <u>ShapingSEQ</u>'s direction to ensure 60% of new development is in existing urban areas.

The online report compares development activity and land supply in SEQ against the benchmarks for housing and employment in ShapingSEQ.

The interactive report allows you to find information for the whole SEQ region or individual local government areas. It's updated annually and is part of the Growth Monitoring Program, which will inform any future regional plan reviews.

### \*\*\* Regional Transport Plans

The Department of Transport and Main Roads is working with state and local government and other key stakeholders throughout Queensland to develop a series of Regional Transport Plans. These plans will guide the planning of an efficient and responsive transport system in Queensland over the next 15 years.

The delivery of the plans is a requirement of the Transport Planning and Coordination Act (1994). The plans provide a bridge between local, Queensland and Australian government planning, drawing from and supporting the region's goals.

#### What is a Regional Transport Plan?

Regional Transport Plans are developed with key stakeholders, including representatives from state and local government, business and industry to prioritise and manage the transport system so that it effectively supports regional communities, growth and productivity.

The plans achieve this by:

- establishing common transport priorities between the Queensland Government and local governments
- communicating our planning intent for the region
- defining the transport systems' role in achieving regional goals and priorities for our planning and investment
- partnering with local government
- guiding future transport planning and investment.

#### Draft Regional Transport Plans for comment

The draft regional transport plans have been developed in collaboration with our local government partners and with input from key stakeholders. The draft RTPs outline the priorities and actions for the future development of the region's transport network.

# **\*\*\*** OSCAR position on election involvement

#### **General principles**

#### It is vital that OSCAR's commitment to non-partisan action is sacrosanct.

OSCAR is, and will remain, non-partisan (not biased or partisan, especially towards any particular political group). However, OSCAR is neither apolitical (not interested or involved in politics) nor non-political (not relating to or motivated by politics).

Whenever we survey potential candidates (as we did prior to the 2016 Council elections and again during the 2017 State election), hold Candidate Forums (as we did prior to the State election, and as member organisations have done at various elections in the past), write to a Councillor, or lobby a Member of Parliament or a State Minister we are operating in the political environment; this is entirely appropriate.

#### Recommended involvement

#### Federal elections

The following activities could be undertaken:

- Candidate survey/questionnaire
- Candidate forums on local government related issues/reforms that are the responsibility of the Federal Government – including, but not limited to, managing population growth policies, share of Commonwealth funding for Local Government, transport and other infrastructure funding, environmental issues etc.

#### State elections

The following activities could be undertaken:

- Candidate survey/questionnaire
- Candidate forums on local government and planning legislation related issues/reforms that are the responsibility of State Government – including, but not limited to, open and transparent governance, RTI reform, planning reform (eg caps on heights and density, use of PDAs and SDAs), donation and expenditure limits, role of business enterprises (eg SunCentral) etc.

#### Local government elections

The following activities could be undertaken:

- Candidate survey/questionnaire
- Candidate forums (Councillor and/or Mayoral) be they Divisional or whole of LGA issues
- Joint activities with one or more member organisations by invitation
- Media releases indicating general support for candidate/s who show/s a commitment to the aims and objectives of OSCAR
- Paid advertising indicating general support for candidate/s who show/s a commitment to the aims and objectives of OSCAR
- Publish and promote OSCAR's priorities/expectations for the next 4 years from a newly elected Council
