- 4.2.2 SCRC Biosphere nomination OSCAR and SCEC still awaiting the selection process result for the Biosphere CRG.
- 4.2.3 Request for additional information on Debt Policy and City Hall financing Greg reported that he is still waiting on information. He has received information from Warren Bunker re debt but is waiting on information re the Council Hall. It was noted that there is some information re the Council Hall financials on the State Government Dept. of Economic Development website as the SCRC has to report to the state as this site is a PDA. Further information might be available following the signing of the Design and Construct contract in early December.
- 4.2.4 LG reform update still underway. Belcara 2A financial reforms SEQA had an update from the relevant departmental officers on Tuesday and individual members will be making initial submissions by Friday 23 August. They will not be finalised before the 202 LG election.
