Q 1 Are you aware of the Principles listed at the beginning of the Local Government Act 2009 and will you commit to abiding by these principles?

	The community has been raising significant concerns in relation to the transparency of the current Council. These must be addressed and I support all measures that will increase community confidence in Council and Council process, including the live streaming of Council meetings and the public release of all Council documents and information as soon as is practically possible.
	There are existing plans that detail how Council services should be delivered and how development, assets and infrastructure should be managed. I will respect and uphold these plans, ensure that the community is consulted and heard, and I will advocate for the community in all my decisions.
	There are opportunities to review and update the Town Plan in the coming months/years. Council's role is to represent the community and I would be guided by the community in relation to any changes/ammendments to the Town Plan.
	I will reset the way Council interacts, communicates with and responds to the community. I don't intend to wait for the community to approach Council with their frustrations and concerns. Council is there to represent the community and I will be present and available, part of the fabric of the community and respond to issues before or as they arise, so they don't become significant problems or a cause for conflict and disappointment with Council.
	I will be seeking out the voices of marginalised members of the community. Council engagement needs to be more inclusive all members of the community including First Nation peoples, young people, culturally diverse people, people with disabilities.

I am standing as an independent with no ties to a political party or interest group and am committed to working in the best interests of my community.

* Treat people in a reasonable, just, respectful and non-discriminatory way

Before moving into the performing arts industry, I spent over a decade as a community worker in SE Queensland and the UK. With a Bachelor of Social Work (University of Queensland), my years working in community and youth organisations has grounded my approach to life and work which is based in the importance of community and the role it plays in individual and societal wellbeing. My professional framework of practice is embedded in the principles of social justice and respect for all members of the community. I will not tolerate bullying, harassment or intimidation towards myself or any member of the community.

* Ensure my conduct does not reflect adversely on the reputation of the Council.

I am very aware that the community decisions I advocate may not always align with the majority of Councillors. I am committed to working collaboratively, responsibly and to respect to democratice process. It is my intention to focus on relationship building within Council, to open up discussion, to seek new voices especially the voices of marginalized members of our community, to devise creative solutions and to work across Council to respond to difficult community issues through dialogue, education and collaborative decision making processes.

Response:

I'm do not support the removal of impact assessments and I am concerned about the use of codes to allow development approvals to proceed without impact assessment. I believe Council needs to advocate for impact assessments regardless of whether complaince is achieved through the Acceptable Outcomes proviso.

Response:

I have a commitment to vigilance, consultation and advocacy and a responsibility to make decisions that will limit or avoid urban footprint expansion into erosion prone areas.

Response:

The reason for proposed rate increases should be clearly communicated to ratepayers and ratepayers should be consulted prior to implementation. The community is already struggling within the current economic climate and Council should not be adding to that burden.
