# Climate change

# Q 9 What do you see as the key impacts of Climate Change on the Noosa Shire?

# Response:

Economic - Forecast higher risks for extreme weather and associated fire conditions, potential for more severe storm events, combined with rising sea levels excerbating flood risk will likely impact our tourism economy and all those business that service it. Similarly, it will result in temporary loss of productivity of local business whether targeting domestic or export markets. We will also see significant threats to one of our largest economic drivers - our beaches, as coastal erosion impacts on adjacent residential premises. Highly contested decisions will need to be made to either protect property or allow the beach to retreat and maintain its utility as a recreational and tourism asset. Either of these options have significant economic imapcts.

Health & Wellbeing - we are witnessing a significant decline in the mental health and outlook of our youth, as a result of their concerns about what may be to come as a result of climate change. Vulnerable age groups and individuals will also be adversely affected by more frequent heat waves, and together with higher seal levels and

more frequent flooding of low lying areas lead to increased mosquito borne disease (e.g. Ross River Fever).

Environmental: The potential impact on some of our most valued aquatic ecosystems e.g. the Everglades, are significant and we are likely to see conditions more suited to weeds reestablishing after disturbance (e.g. fires). Increased frequency of fires may change the species e.g. on coastal wildflower plains. Ocean Acidification and temperature change is likely to upset the current recreational and commercial fish populations as well as marine biodiversity more generally.

# Q 10 How should the Noosa Shire Council deal with Climate Change now and into the future?

#### Response:

Coucnil has already embedded Climate Change consideration throughout its governance, policy and planning frameworks and is recognised as one of the most advanced in the state for its endeavours in this regard. We must continue to be at the leading edge and set the example for others to follow.

The first consultation exercise of the new Council will be going out to the public with the final round of engagement of the Climate Change Adaptation Plan. This plan will seek to to set the priorities for how Coucnil will work with community and industry to address the above impacts ( and more) . Once we have final sign off on the Coastal Hazards Assessment we will also need to amend the New Planning Scheme to reflect the predicted changes to the coastal erosion prone areas etc.

I would hope that Council Zero's Emmissions Organisational Strategy achieves its target of carbon neutrality within this term (i.e. two years before our target of Zero Net Emmission by 2026).

# **Planning issues**

# Q 14 What do you mean by, and how would you measure, sustainable development?

### Response:

The Brundlant Report introduced the concept 'sustainability' and linked it to development, suggesting that sustainable development was a process that "meets the needs of the present without compromising the ability of future generations to meet their own needs" (World Commission on Environment and Development 1987). Some look at it through the lens of 'triple bottom line', suggesting the key to sustainable communities will be to recognise that economic opportunity, ecological integrity, and social equity are interlocking links in the chain of well-being. AtKisson links sustainability to resource longevity, suggesting a society's use of resources, its social patterns, and its pollution emissions are such that they will either go on indefinitely (sustainability), or they won't. For me, Atkisson's seven principles of sustainability probably best sum up our approach to sustainable development In Noosa. They are: think long-term; recognise limits; protect nature; transform business-as-usual, practice fairness; and embrace creativity and foster a shared focus on understanding systems.

At the time Ibecame a Councillor in 2016 I was lecturing at the University of Sunshine Coast in a subject on Regional Sustainability and Change. One of the key messages I emphasised in that course was that we must shift our focus away from concepts that are based on a steady state of the world around us, because the conditons are continually changing. Therefore, when setting measurable targets we should focus just as much on building resilience to change, as we to setting limits of acceptable change. Over the last four years I have championed a more rigorous approach to monitoring and evaluation in our strategies planand you will see many measures of sustainability within them e.g Environment Strategy, the Noosa River Plan etc. Implicit within the New Noosa Plan is a commitment to the long standing approach to growth management; sticking to it is therefore an important measure.

# Q 17 What is your understanding of when it is appropriate to override the Planning Scheme, where there are conflicts?

### Response:

With the adoption of the new Planning Scheme imminent their should very rarely be need to "override" the Planning Scheme (on the basis this is taken to mean approving inconsistent land uses). There may be a one year period during which we accept applications under the old scheme; this may potentially constitute overriding the new scheme on occasion. More generally, on rare occassions, there maybe bona fide reasons why the settings of the Scheme could be 'overriden', e.g. where land identified as flood prone can be shown after more detailed, larger scale investigation not to be so. Each development application needs to be considered on its merits and if new information identifies that the higher levels outcomes of the scheme can be achieved in these circumstances then so be it.

Q 18 With respect to the South East Queensland Regional Plan (Shaping SEQ) that was given effect on 11 August 2017, do you support the Plan in its current form relating to the Northern sub-region, including designation of the Urban Footprint and population targets?

YES/NO No	If NO, will you, if elected to the Noosa Shire Council, support SCRC community groups in advocating to the State Government against this proposal?  I think It consitutes a major conflict with the Regional Plan Settings. It is very similar to the refused approach to a Space Theme Park in the Emu Swamp in the 1980s ( the state government came in a declared the area National Park). It would, in my mind set a bad precedent that may affect Noosa Council in terms of permitting major urban developments outside the Urban Footrpint , in flood prone land etc. However, I can't commit to anything specific in terms of what mechanisms may be appropriate for Noosa Council to take in order to make its views on this issue known.

# General

Q 20a The Noosa Biosphere Reserve designation by UNESCO was recently renewed for another 10 year period. What do you understand is the significance of the Biosphere Reserve designation to the Noosa Shire and its community?

### Response:

I was the Chair of the Environment Sector Board when the previous governance arrangements of the Biosphere Reserve were reviewed. I therefore have a strong affiliation with the designation of the Shire. To me the designation is the recognition of the good work by many in the community since the 1960s, sometimes working with the council of the day, sometimes opposing it; to achieve a balance between human needs and the preservation of our supporting ecosystems and biodiversity. In this term I have brought all of the environmental, community natural resource groups (e.g. Landcare Catchment Management) and community organisations with an interest in sustainable development together into an active network that met on 3-6 monthly basis. The aim of

the network is to build partnerships and commitment to a sustainable future for the Noosa Shire. Working together to ensure our natural ecosystems and biodiversity are valued, cared for, improved and conserved and our lifestyles, urban form and character are protected and enhanced. These features of the local area also underpin our economy. The network also aims to further the goal of the UNESCO Man and the Biosphere Program by:

- Sharing problems and ideas to solve them.
- Development of collaborative projects.
- Learning from others and celebrating success.
- Driving a shared direction toward implementing environment and sustainable development policies, strategies and plans.
- Two-way communication between Council and community groups to foster networks and enhance relationships.

Building greater understanding of, and commitment to, the values, policies and actions that led to Noosa being recognised as a Biosphere Reserve is the ongoing challenge.

# Q 22 In a recent interview the current Mayor referred to a "Crisis" in the Noosa River with biodiversity plummeting. What actions would you propose to address this issue?

#### Response:

I have championed a greater focus in the current draft of the Noosa River Plan on management and rehabilitation of the aquatic ecosystems in the Noosa River system. This is a large challenge. We have started a number of well researched projects. While there is still more investigation required to determine the actions that will have the highest likelihood of achieving a significant impact on the benthic fauna; as a Catchment Ecologist my view is always that it is best to work from source to sea. In this regard continuing the good work to stabilise eroding landscapes and creek banks in the Kin Kin to reduce the supply of sediments which may be smothering benthic habitat; recreating critical elements of the estuarine habitat (e.g. oyster reefs) to provide the structure that will generate greater productivity and biodiviersity in the river; and reducing the factors that are directly impacting benthic habitats (e.g. working with state government with a voluntary beam trawl licence buy back scheme) are the best options at this stage. Ongoing investment in the implementation of the Noosa River Plan by Council, State and Federal Government and phillanthropists is needed.

# Q 23 Given Noosa Shire is an undivided council, if elected, how do you intend to engage with the whole Noosa Shire community?

# Response:

In Short - the same way I have over the last four years. I live in the geographic centre of the shire and it is small enough that I can, and do, ride my electric mountain bike anywhere in the shire for a meeting, site inspection or chat to a concerned resident. For this reason I considered the whole shire my local area, but my home is in the hinterland. It is not a large shire and having experienced the role of Councillor when we had 9 divisions, I am

convinced the current approach achieves the best outcomes for the community and ensures decisions are not made on a narrow parochial basis.

A lot of the communications Councillors do are in fact informal as part of every day life. In this regard I am active in groups across the shire, Vice President of the Noosa Lions Football Club at Sunshine Beach, and a Group Leader of the Noosa Sea Scouts in Noosaville, member and Council's representative on the Noosa Integrated Catchment Association and Mary River Catchment Coordinating Committee and member of Country Noosa and Noosa Landcare in the hinterland. I am always open to a quick chat on Council matters regardless of whether I am there for personal or official purposes.

Once or twice a year I conduct my own "coffee cup consultation" where I invite residents to meet with me over a cup of coffee and discuss issues of concerns across the shire. In this term I also conducted a survey of hinterland residents to identify their priorities. This involved standing in front of the supermarket in Pomona and Cooroy, and at markets in pomona and Kin Kin, going to meetings of local groups and gathering input through an online surveys. The results were then discussed in a workshop with all the hinterland gourps invited to participate.

On top of this is there are numerous opportunities for residents to engage Councillors and staff as part of formal consultation processes.

# Q 24 Why do you think that you are the best candidate for Councillor or Mayor of the Noosa Shire Council?

# Response:

I have a demonstrated commitment to, and active involvement in, the community for nearly four decades. I bring the most relevant experience to the table, with 14 years experience in local government ( seven as a Councillor and seven as an Environmental and Town Planner) as well as extensive government experience ( e.g. Sunshine Coast Regional Director for the Department of Emnployment Economic Development and Innovation and the Department of State Development Infrastructure and Planning). My qualifications that cover geography, local, regional and resource econmics, planning, ecology and natural resource management span nearly every major policy area in council. Most importantly, I bring passion and enthusiasm and will continue to strive to embed the core values of what makes Noosa 'Different by Nature' into every relevant decision.
