Governance, Transparency and Ethical Behaviour

Q 1 Are you aware of the Principles listed at the beginning of the Local Government Act 2009 and will you commit to abiding by these principles?

YES	How do you see them influencing your decision-making? I have 25 years experience in building transparency into government - more than any other candidate across the Sunshine Coast Council elections. I will be seeking to drive change in HOW council undertakes and implements the decisions and priorities it is focused on.
	My experience and my qualifications mean I have a strong understanding of the workings of governments and their various departments at all levels and I use an evidence- based approach to my decision-making. I will not be a councillor who simply reads a recommendation and votes yes or no. I will be undertaking independent research and seeking to engage our community at the front-end of all processes or initiatives that affect our community.
	In this focus I will have a whole of council focus as my role will not simply be to represent Division 5 - it will be to demonstrate a genuine commitment to the whole of our Sunshine Coast.

Q 2a What are the relevant legislation and regulations that govern the conduct of councillors and the activities of council?

Response:

Under section 150D of the Local Government Act 2009 (the Act), the Minister for Local Government must make a Code of Conduct stating the standards of behaviour for Councillors in the performance of their responsibilities as Councillors. In addition to this, the Code of Conduct may contain anything the Minister considers necessary for, or incidental to, the standards of behaviour. Before assuming public office, Councillors must understand and commit to complying with the Local Government principles and obligations of Councillors in accordance with section 169 of the Act, as well as the standards of behaviour set out in this Code of Conduct. All Councillors are required to make a declaration of office under section 169 of the Act. As part of that declaration, Councillors must declare that they will abide by this Code of Conduct.

I do note that in my experience that Codes of Conduct are only as effective as the people who are committed to abiding by them. I hope that Local Government Reforms will mean that these codes are strengthened to have more "teeth" and repercussions for those who contravene the intent and instruction of the codes.

Q 2b How will these impact your decision-making?

Response:

The Code sets out the framework under which councillors behave in delivering their roles to represent the community.

I do not believe the code adequately represents how we engage with community - it seems to still support advising rather than consulting or empowering or co-design. Additionally, there are only a few items that are actually discussed and voted on in Council chambers in comparison with the number of decisions and actions that impact communities. I will advocate for a front-end engagement process across all activities that impact our community.

I believe there are a number of deficiencies in the Code of Conduct and I will be also engaging with community in relation to their perspective of the Code and any potential opportunities we have to refine and strengthen it.

Response:

The primary impact is that we are living an unsustainable lifestyle. We are not taking care of our immediate environment which has longer term impacts - across waste production and management, our use and reuse of water, harnessing the opportunities within the circular economy, building commuting and interconnected hubs and communities that are self sustaining (reducing the need for travel and supporting local economies).

Our increased fire risk and polarising weather events also place significant risk on our built and natural environments. To preserve both we not only need mitigation and management of our natural bushland, we also need to build a holistic approach that showcases better ways to live. The movie 2040 covers some of this.

Q 21 The floodplains of the Sunshine Coast have been extensively filled primarily for urban development. This has increased the risk to people, property, infrastructure and the environment from coastal inundation and flooding and contributes to greater exposure to extreme weather events associated with climate change.

Response:

I will participate through undertaking independent research and engaging with the community to develop further protections against development into erosion prone areas. I would also, if required, work alongside other councillors to influence the State Government on behalf of the community, to respect and enhance measures to protect these areas.

Response: Set in place a policy where rates are aligned with CPI, excepting in an instance where the community as a whole agrees to (via community engagement) invest in a regional initiative and the cost to be met through rating increases.

I believe that debt reduction, reduction of duplication and streamlining activities where possible will reduce the need for rate rises.

Response:

I will engage through the following methods:

- Attendance at community events and group meetings

- A monthly community newsletter via email distribution

This is around the issue of transparency. Community engagement requires a genuine and consistent approach.

For different pieces of work we have different ways in which we consult with the community. Consult can mean many things - and over many years many organisations have argued that informing a community is akin to consulting with them.

Under certain circumstances it is - such as for highly legislated activities. That doesn't change the fact thoughtat we should engage our community from the front end wherever possible.

My view is that we work with our community from the time a project or initiative is identified and then our engagement is a continuum - this is what is viewed in the industry as best practice. Wherever possible I like

work across what is known as co-design - where the community and the council works together to decide and implement a solution.

And for community consultation to be at its most effective we all have to be informed decision-makers. Let say we are looking at a new waste management system. There are many legislated elements to waste management as well as emerging trends and technologies.

Therefore I would begin with an education process - using our website, school tours and education, community briefings, focus groups, workshops, street talks and general media to talk with the community about the options as well as our community values, aspirations and needs.

This gives us the foundation for a proposed set of solutions. We then engage with the community to work through the options - again using digital media, focus groups, general media, workshops, community briefings and other tools to determine preferred way forward.

On selecting the preferred option we then educate the community about the incoming system and what it means for them. Throughout each stage we build community knowledge and participation - we actually a this beyond implementation. The same process stands true for most initiatives.

In extending the Maleny aquatic facilities for example we would work alongside not just Maleny residents be all potential users in the region - through to Montville and out to Kenilworth. We would consult with schools, aged care facilities, child care centres, sporting groups and more. We would work with influencers and decision makers across all levels of government- not just in sport and recreation but also in health and wellbeing. We would engage with health and wellness professionals, the broader swim industry and we would find champions.

Aquatic centres typically make a financial loss. Therefore when engaging and working through this process we would research those options where they are successfully turning a positive financial outcome.

These centres tend to include "value adds" - for instance a fitness centre, rehabilitation facilities, allied heal professionals and more.

This is all part of transparently and thoroughly engaging our community to ensure the best outcome is delivered for the best value.

Q 31 If elected as a Divisional Councillor how will you advance the specific needs of your Division?

Response:

The process I would implement:

- Consult and engage with our community in relation to the individual aspirations and opportunities across our division
- Develop a 10 year plan in partnership with the community
- Cost and prioritise the plan in partnership with the community
- Use evidence-based approach to develop a business case and broader council support for the solutions agreed on
- Partner with broader council and other levels of government to deliver actions and to also advocate and influence in activities that are not the responsibility of local government
- Liaise with the community as partners in the process as the agreed actions and processes are developed and delivered
- Use learnings to refine the plan and actions as progress is made
- Reflect with the community on required pivots or increased focus as the plan progresses.

Q 32 Why do you think that you are the best candidate for your Division or as Mayor?

Response:

I am the only candidate in our Division and in the broader Council area who has:

- 25 years experience across local, state and Federal governments across 4 states
- Decades of experience in delivering in partnership with community waste management projects, reclaimed water initiatives, economic development and placemaking initiatives, infrastructure development initiatives across World Heritage Listed areas, road and bridges development, sustainability initiatives and more. I have not simply read a report and voted yes or no I have worked alongside teams to deliver these projects.

I am the only candidate across the entire council area who has decades of experience in building community transparency and engagement into government at all levels.

In our particular division I have both the skills and attributes to deliver effectively for our community. I have qualifications in project management, community engagement, business management, innovation and entrepreneurship, organisational leadership and business research.

My skills are current and relevant and I have longevity and the vitality to commit to our region. I have experience in delivering complex projects across large geographic and dispersed areas - including Indigenous Welfare Reform in Cape York among other work I have done.

I am able to bring my experiences from across Australia to benefit the whole of our region as well as our division.

Since arriving on the Sunshine Coast I have

- Volunteered to support STEPs Charity an organisation that helps young disabled people build the skills to live independently. Last year I raised around \$30,000 for them.
- Volunteered with the Old Ambo at Nambour helping them secure funding and teaching artists and makers how to build their businesses

I have also

Volunteered for a number of years with various chambers on their committees including Glasshouse
 Caloundra and Montville chambers - working on initiatives to help local businesses gain knowledge
 and skills and helping them to connect with other businesses and government support.

Over many years I have really combined my work and passion to help empower regional communities to secure long term impacts

Just some examples include:

- I've worked with communities to develop placemaking programs to upgrade streets and footpaths, parks and gardens
- I drove the community design and planning for sustainable infrastructure development across the Daintree and Cape Tribulation home to TWO WORLD HERITAGE LISTED AREAS
- In bringing a FINA compliant swimming centre to a suburban council area in Adelaide I worked with senators, ministers at all levels of government as well as the community
- I've worked with various councils, the community, media and private industry to develop and bring new waste management systems to councils in Adelaide and again in Cairns and then in Port Macquarie
- In Cairns I designed and introduced an initiative called Sustainability Street helping suburban famili take actions to save money and resources and show others how simple it was to do so
- I joined forces with the community to design and deliver placemaking projects creating hubs when
 the community comes together one example is Wauchope near Port Macquarie in NSW completely reinvigorating town main street landscapes and precincts.

In South Australia I worked with irrigators, local government and our water authority across agricultural area to develop a fit for purpose water solution and to secure government funding to support this solution.

With this project we reduced effluent polluting the ocean and redirected reclaimed water to irrigators. This meant our landowners had a more reliable water supply and could use more of their land and they were not drawing on the water table. This resulted in us protecting our drinking water supply and reducing infrastructure needs and costs into the future.

No other candidate has this level of experience to bring to our community.
