- 9.2 Travel Behaviour Workshop: Greg Smith advised that no timeframe indicated. SCRC Workshop was how to get population out of cars. Workshops will be held with other stakeholders. Pam advised that the funding announcements for the B2N rail is not the duplication of the line. It is repairs and fixing stations, etc., between Beerburrum and Nambour.
 - Noted that Council is not mentioning CAMCOS. All resources going into Light Rail.
- 9.3 Air Services Australia Sunshine Coast Post Implementation Review Community Meeting (ASA SC PIRC): Charles reported on the 19 September meeting to determine the Terms of Reference with community stakeholders.

While the facilitators tried, the sound was poor and the online participation totally ineffective.

It was a 5 plus hour meeting. Approx. 3.5 hours of this was taken up with Flight Path Forum attempting to have their submission accepted and Air Services Australia rejecting it.

Air Services Australia, SCRC and the Sunshine Coast Airport developed the Noise Abatement Procedure (NAP) which is supposed to minimise noise over residential areas. The NAP's preferred runways for both take offs and landings are over Mudjimba, meaning aircraft are flying over houses at heights of between 200 and 400 feet. General Aviation is coming from Brisbane and Toowoomba to do circuit training with full permission of Air Traffic Control. They are turning off their transponders so as they cannot be identified by those on the ground.

None of the issues that needed to be discussed were discussed, so the meeting was very disappointing.

The next step is Community Noise improvement suggestions to be submitted in October/November.
