Today we lodged our **Applicant's Outline of Argument** at the Planning and Environment Court Maroochydore. This 35 page document is a written statement of the issues and arguments supporting our case that we believe will convince the Court that "Council's decision-maker process failed to take into account relevant considerations, was tainted by errors of law and fell into jurisdictional error. These errors could have materially affected the decision and, as such, the decisions should be set aside the application remitted to Council to reconsider according to law".
