# 9.1 Standing Agenda items

# a) Airport Community Aviation Forum report

- Virtual Meeting held meeting held on the 8<sup>th</sup> of July 2021
- Attendance included State Member and Div 9 Councillor.

#### **Actions from last Meeting:**

- 1. Helicopter Movements: Emergency, Training and Night Flights.
  - Helicopter Movements recorded do include Emergency Flights.
  - In the period reviewed there were 1200 Flights 500 at night and the majority were Emergency.
- 2. Flights Departing away from Designated Flight Path.
  - Observations conducted from the complaint location and all flights departed along Centre Line of Runway.

### **New Business:**

## 3. Sunshine Coast Airport Update:

- No additional Destinations
- New Zealand now all year round subject to travel regulations
- Estimated 14000 passengers (270 pw) pa worth \$18 million pa to Region
- On hold expected to commence late July
- Covid Safety emphasis in Terminal with removal of seating/ additional space created
- Temp Marquees for interstate and overseas arrivals processing for Qld Health and Qld Police
- Terminal Expansion initial planning underway 24 36 Month Project

# Fly Neighbourly Agreement (FNA)

- 5 operators signed up with another 4-5 expected to sign up.
- Lifeflight Emergency have developed a FNP for pilots to reduce impact of operations where practical.

**4. CASA Presentation -** CASA provided an overview of their Role and Primary Function to conduct Safety Regulation of Civil Air Operations in Australia.

### 5. Airservices Australia Update.

- No requirement for transponders in the Airspace around SCA
- This is classified as Class D Airspace
- There was a discussion raised by MRA regarding use of transponders and identifying civil aircraft that were not complying with flights paths and heights on landing and taking off over Mudjimba
- There was an Action point raised to work on further identification and non-compliance
- 259 Noise complaints received between January and May
- Marcus Beach, Peregian and Mudjimba source of most complaints
- New Runway 74% of complaints, Arrivals 13%, Helicopters 5% Night Flights 4%
- Complaints re Arrivals on RW13 58% and Departures on RW31 15%.
- Helicopter Flights 7am to 7 pm 75% of Flights, 7pm to 7am 25% and up to 40% Emergency.

### PIR and Noise Monitoring.

- 5 Locations identified and 3 Noise Monitors (NM) will be in place
- Final choice of locations to be decided and in place by August
- Discussion took place and Action Point raised about the criteria for the NM locations relating to the EIS Findings and that perimeter and central Flight Path locations were used
- Discussion held and Action Point raised regarding the delay in time being experienced in reporting incidents to Webtrack and the importance of each complaint being validated and responded to.

# c) SEQCA - meeting 20 July 2021

Kathleen Florian from the OIA gave a presentation about what and how the OIA undertakes its role. The presentation will be put on the SEQCA website when available. We will let you know and send you the link when posted. She was very generous and spent about 1 and half hours with the meeting. A number of questions were asked: Natural Justice Provisions; the Review process; selective suppression of information from Councillors and/or council officers. Kathleen indicated that the OIA only deals with Councillor Complaints and that matters relating to council decision-making and decision-making processes should be referred to the Queensland Ombudsman.

Owing to time constraints the revised motion relating to Code Assessable development has been circulated with comments back to the Chair This motion is being refined and will be included in the next Update.

We also put to the meeting that SEQCA consider recommending to the State Government that the Economic Development Act 2012 be revised to include principles similar to those included in the Planning Act 2016. That item will be on the SEQCA August Agenda.

QLGRA executive met with Kathleen Florian OIA – minutes of meeting not issued yet.

#### e) Mass Transit update

- OSCAR, Mass Transit submission was sent to all councillors this week. We will try to meet with all councillors over the next few months
- The MT workshop was attended by 14 members with 7 apologies. The outputs from the workshop will be on the OSCAR website on the Mass Transit page by Thursday.
- As advised in the last 2 Updates OSCAR will be making a presentation to the Transport Community Reference Group (TCRG) on August 11. We do know that the developer is continuing discussions with EDQ and in the email response from the Minister's office included the comment ''that a wave pool would add to the tourism offerings of the region'' The campaign continues!!!
