9.1 Standing Agenda items

a) Airport Community Aviation Forum

No meetings since February meeting.

b) Climate Conference – A Climate for Change – an Unconventional Convention, is planned for 14-16 incl. July 2022. We thank the sponsors for their support. The draft "final program" is being reviewed by the wider Conference committee and we hope to have the final version by the end of April. We are currently locking in speakers. The website for the Conference is well underway.

c) SEQCA – Meeting 15 March 2022 – The SEQCA Planning Conference will be held on October 15, 2022 at GU South Bank Venue. Some of the topics proposed include: Reforms needed in the Planning Act to give residents more say in determining the future of their community; Community perspective – how performance based planning works, doesn't work and what can be done about it; the PIA Policy on planning generally and climate change in particular; health impacts of Climate Change and implications for planning; and planning and insurance of homes and businesses in relation to climate change and extreme weather events.

d) QLGRA - No report this meeting as no meeting since last OSCAR GM.

e) Transport CRG – OSCAR and some of its member groups met with State MP Rob Skelton in relation to Public Transport on the Sunshine Coast, including the Mass transit project, the Southern Sunshine Coast Transport Strategy, CAMCOS and the need for PT investment to ensure that the needs of the whole of the Sunshine Coast are being met.

f) Twin Waters West Appeal – The long game

We are still tracking along and now have dates set for the Hearing and lay witness statements.

Hearing date scheduled for July 18 over 4 weeks. Whether the public can attend will depend on COVID provisions at the time.

g) Sekisui Appeal h) Coolum West Members of the Community 6 are meeting with the developer, Don O'Rorke in May. We understand that the proponent was advised by EDQ to meet with SCRC seeking their support for the Wave pool and residential development etc. SCRC has responded to our letter inquiring about the meeting and Council's response. Their letter indicates that at no point did Council give any indication to the developer that Council would change its stance. SCRC advised the developer to meet with the community. We initiated the meeting with the developer, not vice versa.

i) PS 2024 development

OSCAR as the peak residents' group made a presentation to Council on March 31 re our PS consultation response and submission. The Power Point presentation is on the website.

j) Biosphere nomination

Sunshine Coast Biosphere Planning Community Reference Group – Key Messages March 2022

• Council, in consultation with the Biosphere Planning Community Reference Group (CRG), is continuing planning and preparations for the Sunshine Coast to be recognised as a biosphere from mid-2022.

• The CRG recently convened for its third meeting (30 March 2022) where members provided advice on draft performance measures aligned to biosphere objective focus areas.

• The CRG's input to this process is invaluable in ensuring a Sunshine Coast biosphere performance measurement framework is meaningful to the community.

• The CRG provided further input to distinctive Sunshine Coast biosphere branding and fit for-purpose biosphere governance arrangements.

• The CRG has commenced discussion around their potential involvement in pending media activities, in anticipation of a successful outcome in June.

• The CRG's ongoing advice through this planning phase provides valuable community input, ensuring our biosphere is well-placed for long term success during the implementation phase.
