Dear Melva

I refer to your correspondence of 22 March 2023 relating to information resolved by Council to be considered as confidential in its Council meetings. In line with your request in your accompanying email, your correspondence was circulated to Councillors for their awareness.

Thank you for acknowledging the work that Council has undertaken to reduce the extent of material that is considered as confidential information in an Ordinary Meeting.

In relation to your monitoring of such reports, it has been identified through a review of Council records that your data is incorrect. According to an audit of Council records, the number of confidential reports considered by Council across the nominated comparative periods is as follows:

April 2020 – March 2023

- Public Reports 314
- Confidential Reports 27

April 2016 – March 2019

- Public Reports 519
- Confidential Reports 196

As requested, please find attached a table for the period April 2020 to February 2023, indicating the publication status of information that was previously resolved as confidential at the time of consideration, but where Council established preconditions that would need to be satisfied prior to the public release of that information. As you will note, where the information has been published, a weblink to that information has been provided. You will also note that in some cases, the information is not yet able to be released as the preconditions for release, as established by Council, have not yet been satisfied.

Should Council resolve that confidential information contained in a report considered at a statutory meeting may be released publicly at a nominated point in time or once certain preconditions to release had been satisfied, the information is published with the related meeting documentation for the meeting at which the resolution was made. As I have previously advised you on 3 April 2023, a separate register of this material will not be maintained by Council as it is considered this would potentially disconnect the released information from the relevant Council report and related subject matter.

I note you have requested that Council consider establishing a register of confidential items similar to that maintained by Noosa Shire Council. Council has examined the Noosa Shire Council register and considers that it does not inform the community as to what information was considered to be confidential, when material is released or where it can be accessed. Accordingly, in line with the advice above, Council will not be establishing and maintaining a separate confidential items register.

Likewise, as there is now a regularised process established for the release of confidential information once resolved milestones and preconditions set by Council have been satisfied, it is considered to be an unreasonable diversion of Council resources to prepare additional council reports on the status of confidential items (as you have proposed).
