#### Comment:

The Coast or this region was essentially a positive economic place until its agriculture section was dismantled & all the financial & real estate assets that we were endowed with came from those previous geneations Many of these have been squandered in the last 12 years & because we are now a negative economic zone we can not replace them

The last three councils, in particular, have burn our candle at both ends disposing of irreplaceable assets & mortgaged the future with a \$450 million debt. We are descending into a beggar ecomony subsidised by Federal government support payments & the occasional infrastructure project with no prospect of prosperity without a signficant effort to create it

Our plea for infrastructure & the relative lack of response from the other levels of government is indicative of our status as a dorminatory or people dumping ground. It should not be forgotten that cities began to provide labour to industry in our case we are concentrating labour with virtually not industry in need of them

It should not be assumed that there is some entitlement to more than our earned share of the pie. If we want to get what we need we are going to have to get a lot of it for ourselves

# 10 What do you mean by, and how would you measure sustainable development?

# **Comment:**

Sustainable means to not use today materials that can not be replaced infinitely & so will not be available for use tomorrow. There are more general environmental issues that are often lumped together with sustainable & sometimes these cross over

There is also the aspect of using materials or energy today that will require mediation energy to be expended in the future

Sustainable development then means using material that are no exhaustible or if exhuastible can be replaced by other meterial being produced within the ecosystem, which is a long way from what is happening on the Coast at the moment, but producing local energy would be a big step towards achieving some better balance

Sustainable development could be measured by designing an index that incorporated the whole of life energy needs of buildings, vehicles, & other installations done on the Coast. Included in this index would be energy used in construction, the future heating/cooling needs, fuels used, transport, the likely remediation & maintaince energy requirements, & a final recycling of the thing at its end of life.

This could then be balanced against a similar index of local energy generated by activities on the Coast such as agriculture, forestry, recycling, manufacturing, and local energy production

At the moment such an index would show the Coast to be a huge "sink hole" of energy with little emanating from it

11 Do you have any additional comments you would like to make concerning Governance, Transparency and Ethical Behaviour?

#### **Comment:**

I believe ethics to be lacking in all levels of government since marketing techniques now hold sway over most interactions between government & voters

All government officials should act in accordance with a high standard of "in the public good"

Government is after all, the thing that in a democracy organises society for the benefit of the people & business is one of the things that need to be organised for the benefit of the community

If business, the media & government become a bloc acting as they may percieve for the "good" it is unlikely that this good is the public's. Unfortunately, if this happens the economy of a place becomes stagnant as more money is removed from circulation & given to an increasing small number of people or entirely exported from the region

By acting with properity government ensures money is properly distributed in a way to support small businesses which is the natural employer in regional economies

Only be acting with proper governance in an ethical way can government benefit both business & the people in the long term. Short term advantaging business will not create prosperity or even be of benefit to most businesses in an economy for very long

The only reason for not working transparently is in order to camouflage the advantaging of one section, usually large business, over all others

# **Climate Emergency**

12 What do you see as the key impacts of Climate Change on the Sunshine Coast and how should the SCRC deal with this now and into the future?

#### Comment:

Change in weather patterns bring many challenges for councils including more inpacts on all infrastructure, more costs for repair & maintenance of community facilities, more disaster rescues

The inpact of nature on an environment created by a "different" nature will be a complex interplay that we will only experience as it happens. But councils must be aware that nothing will stay the same & must build into their system great flexibility & contingency

Part of this is not overcommiting their future funding to debt financing & be able to quickly switch resources to any new issues that develop

Impact on waterways & foodplains are of particular concern & council should mitergate this as much as possible by restricting development in those zones

# **Comment:**

Yes, but I am unsure of what the curent council has done in practical term to effect any changes within the parameters of that Declaration. I would be more interested in day to day paradigms then adjustment or addition of parameters & measurements

#### Comment:

The Coast could develop local energy proudction, green industries such as hemp growing & use of this in building, green manufacturing. local food production to cut transport energy use & many other initiatives to contribute to Zero '41

The general outline of policies in the PS Zero '41 organisation plan are OK as these things mostly are but misses the opportunity to consider to what degree we could make the Coast a closed loop of growing, recycling, energy generation & reduced transport

Essentially our modern world is based on the idea of inhaustable resources that can produce an endless series of things we need that in turn can use an endless amount of energy to get them to where we need them

Zero emissions concepts should be more broadly based on keeping the energy within things in use as it moves through various states, that is, there is no "waste" just resources in different forms

A careful analysis should always be made of the overall energy saving of local production & the transport energy used in bringing those goods from somewhere else

Despite the PS plans it seems unlikely that we can replace our \$11 billion of imports with zero energy equivalents by 2041. So to balance this we must create an equivalent in positive energy exports or replace imports with local zero or less energy packed products

This entire paradigm becomes much easier if we can balance our imports (\$11 billion) with exports (presently \$5 billion) because in theory we have much greater control over what local production we encourage than we do over the products imported by 10,000s of individuals

But also it is the responsibility of the council to act on the probability of events that will effect the sustainability of our region in a very real sense of future weather events impacting on zones where building likely to be damaged by these events has been placed contrary to likely cost of remediation

As I said earlier a building should be rated in a single meausre of lifetime energy & included in that should be probable energy cost of any remediation

# Comment:

It is a potentially creating a difficult situation by offering relatively cheap land in a location without sufficient public transport or other community facilities in a place that would not have these overlapping from adjacent areas. It would therefore put extra pressure on existing roads with extra private vehicles as the only likely means of transport

Although on the highway it would be difficult to bring any extra transport facilities to such a relatively isolated location. And even if promises were made it seems these are often withdrawn & withdrawing them from this place would have a high probability because of the cost & the lack of other population centres along the route they would take

# **Comment:**

Yes, but the normal processes reject wherever possible applications for development in these zones. Also I would advocate that a system be devised that would fromally inform buyers of the parameters of the locations they are investing in, this could take the form of a document that would include the parameters plus consequences of these such as the unavailability of some insurances & it would acknowledge the buyers have been informed that the council would take no remedial action to preserve their buildings should they be inpacted by ocean erosion, This document would be notorised & returned to the council

I would also advocate for a differential rate system that took into account the probability of buildings becoming unihabitabke or unmaintainable & the likely cost to the community of this. The "whole of life" energy index could be used in calculating the differential rates

# 22 How can the Planning Scheme support the biosphere?

#### Comment:

I understand the BioSphere to be a series of undertakings that the community has agreed to abide by so rather than the PS supporting the BS it seems to me these principles should underlay the PS in more than just words. The various areas designed as BSs are parts of an over-of-region paradigm

# **Comment:**

I believe a responsible council should turn away from development near the waterways & floodplains because the future impact on these zone is calculable & therefore it is known they are unsustainable in that they will cost the future resources to maintain & protect them

# **Comment:**

I have some reservations about making the needs of the Olympics a primary determinate of transport budgeting. The general aphorism is "The Olympics cause to be built things for which there was no demand before them & will be no demand for them after"

Also this idea there will be a Olympic bump in the infrastructure budget may proved to be an illusion especially in our region where already basic promised projects unrelated to the Olympics have been canceled & it is doubtful whether funding would be restored to all those by 2032

As a rough back-of-the-envelope guide if the Feds 10 year infrastructure is \$600 billion proportionally we may get \$8 billion & that, even with a State top up. won't provide much more than our basic needs

It may not be appropriate to discuss it here by the region should have a closer look at not the vague legacy benefit of the Olympics but the actual real time financial pay back & also the value in dollars of such legacy effects as increased tourism

As to the ratepayers financing any major infrastructure it is inconcieveable that at today's escalated cost of consturction our 160,000 or so ratepayers can afford very much at all but what is troubling is the invisible cost of millions being spent by the council in investigating spurious options & lobbying for these
