TIVIK Presentation	Scott Whitaker, Regional Director (North Coast) Department of Main Roads and Transport Scott outlined 9 Major projects his department are currently working on. MRI Stage 1 Sunshine Motorway Upgrades Bells Creek Arterial Rd Kawana Motorway Caloundra, Bells Creel, Kawana Way Link Road Interchange Northern Public Transport Strategy Direct Sunshine Coast Rail Line Sunshine Coast Public Transport Project Beerburrum to Nambour Rail Upgrade Scott indicated in order for the majority of the projects to occur, the Rail duplication and the completion of the MRI are needed. Scott indicated the likely timing for the completion stage 1 and stage 2 of the MRI (if funding is secured) would be 2030. It was also noted that if funding for the Sunshine Coast Direct Line was secured now, it would be a struggle to get it delivered by 2032. He confirmed it could be delivered in sections. It was noted that his department has no control over what does and does not get the go ahead and funded.
