3 If elected, how do you intend to engage with your community and/or the region?

Comment:

I have always made myself available to meet with anyone from any Division. I manage my own Facebook page and on big issues I have and will continue to put a press release out. I have also maintained two meet the councillor session per month, one a Kawana Library the other at Cotton Tree Library. I do go to many invited events like Chamber of Commerce, and other community-led events, but not limited to my Divisional boundary.

4 If elected as a Divisional Councillor, how will you advance the specific needs of your community?

Comment:

The battle front initially will be the draft town plan which I am keen for the new council to review and reduce the excessive density in Division 4. I am also mindful that the Central Meeting Place and Seawall timeframe is challenging for the community and I am happy to push for a delay until the community is comfortable with what council is proposing. I will make sure when the draft town plan finally is out for public consultation that I notify owners on every street in my division where change is intended to happen and let them know what the current building height is and zoning and what the proposed changes are.

5 Why do you think that you are the best candidate for your Division or for Mayor?

Comment:

I have demonstrated I understand the key issues my community are faced with and during the last term I was able to voice strongly my objection to the direction the council was heading with Mass Transit, the New Town Plan, the foreshore works at Mooloolaba, the sale of the residual Brisbane road car park, the reduction in height and density on the northern part of the Buddina Urban Village, the Pt Cartwright and La Balsa Park Master Plan, the initial M2M bikeway just to mention a few. I have committed to a very high level of customer service where I attempt to respond to all my emails on a daily basis except for Friday night, however by Sunday evening all emails are done and actioned. I have a very high level of attendance to many community and business events. I have 15 years of experience and my decision making process always puts the interests of the community first.

6 Do you have any additional comments you would like to make concerning this section of the survey?

Comment:

My 15 years as a councillor and as mayor of Maroochy Shire, speaks for who I am and what I stand for. I am committed to honest, accountable and transparent government. If elected the next four years will be more of that hard working commitment and service to the community. My decision making has always been balanced between the need to grow sustainably, ensuring the environment does not suffer as a result of that growth. My voting has always been made on the basis of what is best for the majority within our community, and I have never voted for the purpose of being reelected.

Comment:

I have a very high level of commitment to the principles of the Local Government Act. As an example of this I voted against the Corporate Plan at the Februay 2023 Ordinary Meetting when it was clear the council was going to deliver the high density in the Coastal Urban Corridor to underpin the Mass Transit Detailed Business Case even though the draft planning scheme was not yet out to public consultation. I argued that one of the principles of the Local Government Act states that when council undertakes public consultation it must be done in a meningful way. I could not see this was possible when the Corporate Plan was set to deliver that level of density irrespective of what the community might say during the Planning Scheme round two public consultation period.

It is important for a councillor to maintain a high level of awareness as to ensure compliance to the legislation and regulations that govern the code of conduct and activities of council is upheld at all times.

10 What do you mean by, and how would you measure sustainable development?

Comment:

Sustainable development is what I aspire to achieve, I look at all developments on how they impact the surounding community and the environment. I consider the ecological footprint and in particular design for our climate. I consider distances to services and what the carbon footprint will be in travel miles. I take in the impact on our existing infrastructure and whether it can cope or have a negative impact. The final measure is the impact on lifestyle of those who live around a particular development, in all of these measures I evaluate whether it would lead to a positive or negative outcome.

11 Do you have any additional comments you would like to make concerning Governance, Transparency and Ethical Behaviour?

Comment:

Too often confidentiality is used to avoid proper scrutiny. The state government must make it mandatory for a planning report to indicate if a direction has been given by the CEO or the CEO's representative to a planning officer to provide a recommendation against the officer's professional opinion and recommendation. The front page must contain the planning officer's proffesional opinion and recommendations and reasons for it, and it must then state clearly that the CEO is recommending an alternative recommendation. This must be legislated and failure to disclose this would result in a criminal offence with a mandatory jail sentence if found guilty.

Also any conflicts of interest on any DA by a mayor or councillor triggered by an election donation should not be put to the vote by councillors if the councillor or mayor believe they can make an unbiased decision, but an automatic exclusion to participate and vote should occur.

Climate Emergency

12 What do you see as the key impacts of Climate Change on the Sunshine Coast and how should the SCRC deal with this now and into the future?

Comment:

The severity of storms is of enormous concern for me on coastal communities which will be subjected to storm surges, gale force winds, tidal inundation, flooding. The settlement pattern set by the 2016-20 council places a very large amount of our future infill density along these low lying areas and places this population right at the front of any severe cyclonic event with potential massive impacts. My greatest fear is that many of these residents in the future may not be offered flood insurance. Building on any flood plain is crazy and should be avoided completely. I have openly supported density around passenger rail away from the coast. There is an opportunity to build a modern city around density at Beerwah East from the beginning. It is the most cost effictive way to manage growth and lessen the impacts on the coastal frail edge.

Comment:

Yes, I seconded the original motion moved by Cr Law, and I have taken a key interest to ensure council can deliver on the objectives set.

Comment:

Getting the population settment patterns right for a start will do more for establishing a much better public transport network, with the priority being to shift greater numbers towards public transport. The council must play an active role in promoting the benefits of reducing energy cost and the savings which can be made in doing so, it is a win-win for all involved.

Comment:

State government must manadate energy efficiency in hot water systems, house appliances. I believe green hydrogen is the future for council's heavy vehicle fleet and council needs to explore this more agressively. The same with working with Energex to convert all street lights to LEDs.

Planning issues

Comment:

It is best to use an example. Twin Waters West should never have been moved from rural to Future Urban. Any development on that site with recommendation of approval is hard to support the planning scheme when it is clear such a development will have impacts on those properties below the highest probable flood level. Knowing these homes may never get flood insurance it was impsiible for me to support the planning scheme based on a bad previous council decision to allow urban development on this land.

Comment:

The community never had a chance to make any comment about the expansion of the northen part of Yandina. I struggle to see how the intrinsic values of Yandina can be maintained with this expansion and impact it will have. The Sunshine Coast needs a major review and understanding on the growth impacts to our region, our brand and our point of difference to the Gold Coast. We need to define clear boundaries which are inpassable. These boundaries define what are the Sunshine Coast values and lifestyle worth fighting for and maintaining forever. This then drives all decisions on growth in the future. The boundaries must be well articulated and the community must have strong ownership of them.

21 The coastal hazard "erosion prone area" is defined by the Queensland Government. The State Planning Policy Guidance states redevelopment is to "avoid urban footprint expansion into erosion-prone areas while the State Policy prohibits this land "to be used for urban purposes" unless already located in an urban area or urban footprint in a regional plan.

Will you oppose increases in the urban footprint and the density of medium and high-rise mixed-use residential buildings in these designated coastal hazard areas to reduce overall risk – and if so, how?

Comment:

Yes I will oppose it. These areas must remain low residential to avoid large buildings being built on them. It should even exclude dual occupancy on them as well, minimise any potential loss if erosion threatened property. Move taller buildings away from sensitive coastal areas.

22 How can the Planning Scheme support the biosphere?

Comment:

The planning scheme needs to acknowldge human impacts and the impacts of the built form on the natural environment. The planning scheme should be sympathetic to the turtle nesting beaches and not support tall buildings which impact the beaches by increasing the skyglow. It should reduce heat sinks in built up areas with more deeper plantings and the promotion of an urban forest.

23 Do you have any additional comments you would like to make concerning Planning Issues?

Comment:

There are too many code assessable developments which remove third party appeal rights. Council should agree to notify neighours to a code assessable application being lodged. The discretion by officers to interpret a code assessable application is extrodinary. Relaxations in density and site coverage have gone beyond what one would believe is reasonable. I believe if any application requires a relaxation of 15% or more on some of the key fundamental components of a planning scheme like density, site cover and boundary relaxtions this should automatically trigger the DA being decalred an impact assessable application.

Transport Infrastructure and Service
