# 9.1 Standing Agenda items

#### a) SC Airport & Community Aviation Forum -

The Sunshine Coast Airport Priority Development Area (PDA) was declared by regulation on 28 July 2023. The PDA covers 460 hectares of land in Marcoola on the Sunshine Coast. The Airport is a key domestic and international gateway to the region.

The Airport has been identified in Shaping SEQ 2023 as major enabling infrastructure to support the northern gateway regional economic cluster and contributes to the continued economic growth of the Sunshine Coast region.

The Interim Land Use Plan (dated July 2023) is in effect until a PDA Development Scheme is finalised, later in 2024.

Development in the PDA will support the growth and expansion of the Sunshine Coast Airport. The Development Scheme will provide for uses that can capitalise on the proximity to direct export markets to support the creation of a modern competitive airport precinct servicing staff, passengers, visitors and residents.

**j)** Twin Waters West Update – Twin Waters West and Surrounds, OSCAR and Development Watch have sent a letter re the Twin Waters West approval by SCRC to the Premier and several Ministers seeking a meeting with them. The letter is on the OSCAR website. To date there has been a phone call response when the officer was requested to send a written response given there are 3 groups involved. That was some weeks ago – still no written response. This is being followed up.

TWWS have contacted EDO seeking advice on some of the issues raised in the letter to the Premier and Ministers.

#### TWWS have tabled a petition in Parliament which states:

TO: The Honourable the Speaker and Members of the Legislative Assembly of Queensland

Queensland residents draws to the attention of the House concerns with a development approval granted by the Sunshine Coast Regional Council on 14 December 2023 for an estate with a saline constructed waterbody on flood-prone land MCU 23/0113.

The development is a significant subdivision on undeveloped and constrained land adjacent to the Maroochy River. We consider that the application demonstrates that this development conflicts with state interests and provisions of the Planning Scheme in that it impacts conservation areas and off-site flood impacts. We hold concerns the council has not performed its responsibilities properly demonstrated by approving an application that is incomplete, conflicts with the Planning Scheme, and clearly demonstrates significant adverse impacts to state interests within the State Planning Policy 2017 (SPP).

This approval has impacted public perception in relation to due and proper process in decisionmaking by our local government.

Your petitioners, therefore, request the House to do all in its power to ensure that there is an efficient, effective and accountable planning and development assessment system, which is also a state interest, and we request by way of remedy the use of ministerial powers that are responsible for the policies, decisions and actions of departments and agencies to correct such errors brought to their attention.
