9.1 Standing Agenda items

- a) **SC Airport & Community Aviation Forum** – OSCAR and member groups Development Watch, Mudjimba Residents Association, Marcoola Community Group, supported by Friends of Yaroomba made a submission to EDQ re the Proposed Master Plan for the Gateway Precinct of the Airport. Issues raised include: bulk and scale of the plan, traffic levels of service, 10 storey heights, creating an industrial site, including possible buildings that have no relation to aviation, eg a multi storage block adjacent to residential dwellings and a 10 storey office block that impacts view lines and scenic views to Mt Coolum. OSCAR's submission is on the OSCAR website home page.
- b) **SEQCA** – AGM Tuesday 25 November at 9:30am at Griffith University South Bank followed by a Morning Conversation - 10.30-12.30 pm followed by lunch at Southbank Siam at own cost. Monthly meeting is 18 November via ZOOM.
- c) **Transport: TMR/SIG**- no meetings have been held since both Local and State elections. In our PS submission OSCAR called for SCRC to re-establish a genuine 2-way communication Transport CRG.
- d) **2025-26 Planning Scheme** – OSCAR's submission is on the website. We have withdrawn any endorsements of other group submissions.
- e) **Pacific Paradise Service Station appeal** – a short presentation will be made at the November GM re the implications of this case for other development decisions and court cases.
- f) **Biosphere Update – Biosphere Festival** -
